## **2021 KOSA Annual Mardi Gras Parade** **Vendor Registration Policies:**

- \*\*Vending availability is based on a first come, first serve basis. We will not hold or accept spots for the 2021 event without pre-payment. All vendors must comply with all local, state, and federal tax and revenue reporting.
- \*\*Vendor spot location is based at the discretion of Legistix Solutions LLC. We will honor a first come, first serve basis for vendors who have completed applications and paid in full.
- \*\*All vendors are required to maintain their space and clean up after an event.
- \*\*All vendors are required to adhere to the laws and regulations of Bay County, the State of Florida, and applicable business regulations.
- \*\*Legistix Solutions LLC and the Krewe of St. Andrew's have the right to cancel a vendor's contract within 48 hours of event official start time. 100% full refund will be given in the case of cancellation.
- \*\*No Refunds will be issued if a vendor does not show up for an event. Event is rain or shine.**
- \*\*Food vendors will NOT be charged a one-time deposit fee. Please clean your area for consideration in future events. You all did a great job last year, please keep it up and we won't charge deposits.
- \*\*Approved vendors are NOT allowed to transfer their vending rights to any other vendor without written permission from Legistix Solutions LLC.
- \*\*Food vendors are required to put down necessary protection if using hot grease in food preparation.
- \*\*Set up time is tentatively scheduled to begin at 10:00 AM on Friday May 21st, 2021
- \*\*Space requirements for vendor booths will be strictly enforced. Extensions will not be allowed.
- \*\*Vendors provide all necessary materials for vending. (Tents, tables, chairs, etc.) Legistix Solutions will provide electricity.
- \*\*All food vendors must comply with the State of Florida-Hotels and Restaurants Division laws and regulations for vending. For more information please call 850-487.1395.
- \*\*Rain Policy: No refunds if event runs according to schedule.
- \*\*Please remit your re-sale certificate, Insurance, and Tax ID number on this form at time of payment.
- \*\*Vendors must remain open for the entire time of event.
